ANNUAL STATEMENT - 2016-17

1 - The institution Chhotanagpur Kalyan Niketan and Land Revenue Branch- Khatian's computer data entry work was done in all the villages of Simdege District Kolibira Block, in which Khatian was integrated by about 20 operators. In which all necessary information related to account number land is available. Theko operators entered Khatiyani Koshi language by revising it in Hindi language. It was supported by all the concerned employees, who inspected the entry F1 and F2 and F3 in which the operators worked very closely in the server. This work was done under the supervision of the Edison Collector.

2- The families below poverty line have been protected with social security insurance and group insurance with the help of the institution and P&G. Along with this, programs were organized under social security in Meromdega and Kasadega villages of Meromdega Panchayat. Its importance was conveyed among the villagers. Panchayat codinators of the organization, Kishori Meher and Lilavati Devi, were also told to protect women, Safe person is said to give a scholarship of twelve hundred rupees to his children who are in ninth and twelfth year. 40,000 rupees in case of simple death and Rs. 85,000 on accident, along with various insurance of the government. There is also an AC incident stated by the ward in which after the death of the guardianship of the house, suddenly the family is stunned by the burden on his wife or the person based on him, which can help the family again with this insurance. This insurance protects the insured person in case of any physical accident with a person, whether it is a complete physical accident or even in that case. All the villagers present in the meeting listened very attentively. It was also stated that group insurance always gives Rs 10,000. Aam Aadmi Bima Yojana gives a claim amount of Rs 30,000. Ward, Sahia, courtyard fence and a large number of villagers were also present on the occasion.



3- Family-based care program was celebrated on the occasion of Children's Day in Simdega district with the joint support of the institution Chhotanagpur Kalyan Niketan and Srujan Foundation Ranchi, in which many officials were present at the district level, along with the ward, head, children, members of the bloc A program was organized among the members, courtyard workers, teachers, and others in which any child (under 18) was told The rods have been or single parents; What is the procedure for someone whose parents have died or are suffering from some kind of victimization? What to do, it was told by Madam Pushpa Sharma of the creation foundation, for this, the child protection officer and other member also told about it. Where the child lives and what kind of punishment is given to them, they were explained in detail along with the needy children. The representative of the Bal police station told how the police should behave while arresting the children and how they should treat the children. In this way, the immediate members of the BLB also expressed their intention that the song was sung by all the children present and the program was also presented. The labor officer Mr. Baban Singh also told the children and all the people present to be the number of the child line. If you see a child laborer anywhere, then on calling the child line, they will come and take the child from there and present it in front of the boy. The District Statistics Officer has said that this is a good initiative of the institution, which is ensuring the rights of children. This type of program should always be there and we all should be aware. Child Protection Officer, District Statistics, Tatkali JJ Board Member, Tatkalin Blab Member, NGO Children (Rural), Ward Anganwadi and others were also present on the occasion. Block level work was also done by the organization at the block level.



4 - In association with the institution Chhotanagpur Kalyan Niketan - the month was celebrated as AIDS Day in which about the AIDS among the students and students of the college, in which AIDS was touched by Sister (A grade nurse) Milani Kujur. In the end everyone told that dowry is not taken in our panchayat. From the girl's favor, what she gives as female money to her daughter remains with the girl. This was also accepted by women. It was felt during the program that the women and adolescent girls looked very happy and got a good chance to speak on stage. And she was talking excitedly. During this time, women were remembering their marriage and telling them about it. The girls were excited about their upcoming life and were participating in the competition well. The girls were questioning one by one, then at the same time they were also answering it, if the dowry is stopped then no girl will commit suicide for dowry or no parent will consider their daughter as a burden. Like all parents, the son will raise the daughter and teach them. Against dowry, we should have an organization in every panchayat, which can raise voice against the dowry taker and reach the concerned officer. Everyone got excited and made the program successful by sending a message to the villagers that taking dowry is a bad thing and giving dowry is also a bad thing. Both are guilty, punishment is equal for both. All the villagers contributed commendably in making this program a success.



3- What are the facilities provided to women under the 'Domestic Violence Act 2005' by the organization and how is this Act used. Regarding this, a competition program was organized among the students of Nursery Teacher Training. In this competition, an issue was given among the students. On top of which the students had to write and write their slip in a closed box, if there is violence with the woman, then where should she be informed first of all, how can the information be given. If a woman is molested, what steps should she take, what are the types of violence in the Women's 'Domestic Violence Act 2005'. like this. The question was raised in the competition. Through this competition, a kind of courage and knowledge of passion was filled in the students. Information related to women's law was also given by the women in-charge of the police station, along with the information about the poxo. Nursery teacher training's instructor and the head of the university contributed a lot to make this program a success.



4- In association with Chhotanagpur Kalyan Niketan, the organization was celebrated as a women's gathering among women on the occasion of 'Women's Day' in Simdega block of Simdega district. In this meeting, some women who narrated their story (AAP), how they first took the violence with the guidance of the organization and how they have done, how they and their family are happy with their action. In which Sumati Devi (name changed) of Simdega, Mala Devi (name changed) of Ranchi, both of them told you the story of the past, a woman with courage in the suffering women Anita Devi (changed name) of her and her husband's life The whole story told how the child handled his life after divorce. Women likewise encouraged each other. And told about his earlier life and later life together, All the women together made this

day memorable by celebrating with laughter and took courage from each other, now it is no longer the era that women were considered to be the property of the house. "A word will always hum." Around 150 women sisters were present on the occasion.



5- The institution of Chotanagpur Kalyan Niketan and Statistics Department, Simdega- The computer population of the National Population Registrar of all the blocks and wards of all the city councils of Simdega district was done by the organization, to do this work by 52 computer operators in which the operator Entered online and examined by the crowd. It was also loaded on the website after investigation. During this time all the work was done on the departmental server. This work was successfully done by the institution.
